On the recommendation of J&K Services Selection Board, Jammu, sanction is hereby accorded to the appointment of Nusrat Rafee D/o Mohd Rafee Khan R/o Diyarwani, Batamaloo, Srinagar against the post of Jr. Scale Stenographer in the Pay Level 6 (35400-112400) advertised vide Notification No. 03 of 2012 dated 28.12.2012 under item No. 117 (OM).



The appointee shall report to the Director, Handicrafts and Handloom, Kashmir within a period of 21 (twenty one) days from the date of issuance of this order and shall be allowed to join only on production of following certificate(s) in original to be verified subsequently by Director, Handicrafts and Handloom, Kashmir:-

- i. Academic/Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the district.
- v. Certificate from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under Self Employment Scheme has been taken by the appointee.

The appointment of the appointee shall further be subject to the following conditions:-

(a) That she shall give an undertaking in the shape of an Affidavit duly attested by the 1st Class Magistrate to the effect that:-

- i. *In case adverse report about her Character Antecedents is received from the Special Director General of Police, (CID), J&K, to whom a reference shall be made by the Director, Handicrafts & Handloom, Kashmir, she shall have no right to claim her appointment as Jr. Scale Stenographer in the J&K, Handicrafts & Handloom (Subordinate) Service and her appointment, as such, shall be deemed to have been cancelled ab-initio;*
- ii. *If, on verification, genuineness of the qualification certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Jr. Scale Stenographer shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.*

- a. The salary of the appointee shall not be drawn and disbursed to her unless the satisfactory report in respect of (i) and (ii) above are received in her favour.
- b. The appointee shall be initially on probation for a period of two years.
- c. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- d. If the appointee fails to join within a period of 21 (twenty one) days from the issuance of this order she shall forego her right to her appointment which shall be deemed to have been cancelled ab-initio without any further notice.
