Subject: - Release and advance drawal of funds under Capex Budget 2021-22.

Government Order No:- 174 Ind of 2021
Dated:- 03 -09- 2021

Sanction is hereby accorded to the release and advance drawal of funds amounting to Rs.1250.00 lakh (Rupees twelve crore & fifty lakh) only under Capex Budget 2021-22 in favour of Director Finance, Industries and Commerce Department for its drawal and further placement at the disposal of Secretary/CEO, J&K KVIB for disbursement of margin money under J&K Rural Employment Generation Programme (JKREGP) in favour of sanctioned cases/beneficiaries through J&K Bank as per the relevant scheme guidelines.

The advance drawal is subject to following conditions:-

1. The amount of margin money shall be disbursed to the beneficiary through DBT mode.
2. Tracking of individual beneficiary shall be ensured by the Board and success rate may be communicated to Administrative Department and Finance Department.
3. The expenditure shall be made after observing all the required codal formalities and with approval of competent authority.
4. There shall be no diversion/deviation in any case and funds shall be drawn if immediately required and not just to park in the bank account.
5. The Red DC accounts shall not only be sought but invariably furnished to the concerned quarters within stipulated time.

The expenditure shall be debit-able as per following classification:-

Demand No:	=11
i. Major head	= 4851 – Capital Outlay on Iron & Steel Industries
ii. Sub-Major Head	= 00
iii. Minor Head	= 105- Khadi & Village Industries
iv. Group Head	= 0011- General
v. Sub-head	= 0365- Assistance to Khadi & Village Industries Board
vi. Detailed Head	= 115- Works.


