Dated: 21.10.2021**

As recommended by the Jammu and Kashmir Service Selection Board, sanction is hereby accorded to the temporary appointment of 14 candidates as mentioned in Annexure-I to this order, against the posts of class-IV in respective Division/District Cadre in the Directorate of Industries & Commerce, Jammu in the pay Level SL1 of Rs. 14800-47100, with immediate effect.

The appointees shall report to the Director, Industries & Commerce Department Jammu in Udyog Bhawan, Railway Head, Jammu within a period of 21 days from the date of issuance of this order. Those who fail to join within the stipulated period, their appointment shall be deemed to have been cancelled without any further notice.

The appointees shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Technical Qualification Certificates.
- ii. Matriculation /Date of Birth Certificate.

- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the competent authority.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Valid relevant category certificate, if required.
- vii. The candidates shall also furnish an undertaking in the format at annexure II.

The salary of the appointees shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates is received.

Further, the appointments have been made in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020 and shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution. The Cadres/Departments allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department. The inter-se seniority of the appointees shall be as per the merit as it exists in the select list

The appointments are subject to outcome of any petitions/(s) pending in any competent court/ Tribunal etc.
