Subject: Deputation of Mr. Sajjad Mohi-ud-din Banday, Public Relation Officer (Dy. Manager), J&K Cements Ltd. to SIDCO.

Government Order No. 209 IND of 2021

Mr. Sajad Mohi-ud-Din Banday, Deputy Manager of JKCL presently deployed in Geology & Mining Department, J&K is recalled and is deployed to J&K SIDCO for a period of one year against the available vacant post of direct recruitment quota. The services of Mr. Sajad though are temporarily placed at the disposal of MD JKCL to assist in finalizing the accounts and audit related matters of JKCL. The deployment of the officer shall however be subject to the following conditions:

- i. The salary of the official shall be drawn by the MD SIDCO against the available vacancy of Direct Recruitment Quota as per the LPC issued by the Director, Geology & Mining, J&K and without any deputation/deployment allowance.
- ii. COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation.
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of the official.
- iv. The salary shall be released in favour of the official from the date he join duty.
- v. He shall retain his lien, seniority and promotion prospects at his parent Corporation viz. JK Cements Limited.
- vi. The official shall remain on the rolls of J&K Cements and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.
- vii. The above arrangement shall be reversible without any notice.
- viii. The post vacated by the official in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.
- ix. The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he has no right to claim for permanent absorption in the corporation and will not approach any Hon'ble Court of Law for the said purpose.
- x. The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Director Geology & Mining, J&K in his LPC to be issued by him.

The Managing Director, SIDCO shall draw his salary on production of monthly attendance from MD JKCL till the official physically joins the Corporation.


