Sanction is hereby accorded to the deployment of Sh. Satish Kumar, Project Manager, Handloom & Handicrafts Development Corporation and Mr. Obaid Reyaz, Manager (HR) JKEDI presently deployed in JKTPO as Deputy General Manager to JKI initially for a period of two years to utilize their services at newly established unit at Bari Brahmana Jammu and Woolen sector of Kashmir based units respectively subject to the following terms and conditions:-

- i. *The salary of the officers shall be drawn by the Managing Director, JKI against the available vacant post as per the LPC issued by the Managing Director Handloom & Handicrafts Corporation and Director/Executive Director JKEDI without any deputation/deployment allowance.*
- ii. *COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Institutions.*
- iii. *No arrears on account of pay or COLA/DA shall be paid in favour of the officers.*
- iv. *They shall retain their lien, seniority and promotion prospects at their parent Corporation viz. JK Handloom & Handicrafts Corporation and JKEDI.*
- v. *The officials shall remain on the rolls of J&K Handloom & Handicrafts Corporation and JKEDI respectively and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vi. *The above arrangement shall be reversible without any notice.*
- vii. *The post vacated by the officers in J&K Handloom & Handicrafts Corporation and JKEDI shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- viii. *The officers so deployed shall furnish an undertaking duly attested by the 1<sup>st</sup> Class Magistrate stating therein that they have no right to claim for permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.*
- ix. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director Handloom & Handicrafts Corporation and Director/Executive Director JKEDI which shall be reflected in the LPCs issued under their signatures.*

- vii. The post occupied by the officers in JK Handloom & Handicrafts Corporation and JKEDI shall be deemed to have been filled and shall not be filled up by promotion or by direct recruitment.
- viii. The officers so deputed shall furnish an undertaking duly attested by the 1<sup>st</sup> Class Magistrate stating therein that they have no right to claim for permanent absorption in the department and will not approach any Honble Court of Law for the said purpose.
- ix. The Pay level and designation shall not be taken as a matter and shall be subject to further verification by Managing Director Handloom & Handicrafts Corporation and Director/Executive Director JKEDI which shall be reflected in the LK issued under their signatures.
