**Subject: Extension in deputation period of Mr. Malik Junaid, Junior Engineer,
J&K Cements Limited to the Directorate of I&C Kashmir.**

**Government Order No:- 219 - IND of 2021
Dated:- 09 - 11 - 2021**

In continuation to Government Order No. 198-IND of 2017 dated 16.08.2017 followed by Government Order No. 216-IND of 2019 dated 18.10.2019, sanction is hereby accorded to the extension in deployment of Mr. Malik Junaid Ahmad JE (Chemical) of J&K Cements Limited to Directorate of Industries & Commerce, Kashmir for further period of one year from the date the term of his last deputation expired viz. 16.08.2021 subject to the following terms and conditions:-

- i. *The salary of the official shall be drawn by the Director, Industries & Commerce, Kashmir against the direct recruitment vacant post available in the Directorate of Industries & Commerce, Kashmir without any deputation/deployment allowance.*
- ii. *COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Institution.*
- iii. *No arrears on account of pay or COLA/DA shall be paid in favour of the official.*
- iv. *He shall retain his lien, seniority and promotion prospects at his parent Corporation viz. J&K Cements Limited.*
- v. *The official shall remain on the rolls of J&K Cements Limited and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vi. *The above arrangement shall be reversible without any notice.*
- vii. *The post vacated by the official in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- viii. *The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he has no right to claim for permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.*
- ix. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director, J&K Cements Limited.*
