1. That the proposals are strictly devised as per the latest relevant I.S Codes and specifications of PWD/CPWD and is authenticated and proof checked by the competent authority (NIT/DIQC).
2. Those Electrical/mechanical components are authenticated and technically vetted component Authorities of relevant field.
3. That the rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.
4. That the Lump sum provisions, either in terms of percentage or fixed as made for certain components of the DPRs are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.
5. That e-tendering mode is followed for fixation of award of contract for execution of each project. Fragmentation of project, while tendering, is not allowed.
