The Accord of Administrative Approval is further subject to the following conditions:-

1. That the proposal is strictly devised and designed as per the relevant Code of BIS/CPWD Manual/IRC Code specifications.
2. That any such item(s) not covered under relevant schedule of rates shall be paid in accordance with the set codal Procedure.
3. That the procurement of Testing Machinery be made as per BIS standard.
4. That the NOC if required from Regulatory Authority may also be sought before the procurement process.
5. That the Lump sum provision shall be subject to actual measurements/quantities and relevant schedule of rates with adherence to set codal procedure.
6. That e-tendering mode/ proper codal procedures as mandatory for finalization of award of contract be followed and working DPR adopted in the advertised BOQ. Fragmentation of project while tendering to be avoided.
7. That proper rate analysis and market survey has been conducted in light of standing rules and procedures.


