As recommended by the Jammu & Kashmir Services Selection Board, sanction is hereby accorded to the temporary appointment of Mr. Manik Singh S/o Mr. Pawan Singh R/o Nagri Parole Mirpur Ram Kathua, under OM category, against the post of class-IV in respective Divisional/District cadre in the Directorate of Industries & Commerce Department, Jammu in pay Level SL1 of Rs. 14800-47100, with immediate effect.

The appointee shall report to the Director, Industries & Commerce Department Jammu in Udyog Bhawan, Railway Head, Jammu within a period of 21 days from the date of issuance of this order. In case he fails to join within the stipulated period, his appointment shall be deemed to have been cancelled without any further notice.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Technical Qualification Certificates.
- ii. Matriculation /Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the competent authority.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Valid relevant category certificate, if required.

The salary of the appointee shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates is received.



Further, the appointment has been made in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 of 2020 dated 17.06.2020 and shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one, at any stage later on. He/she shall also be liable for criminal prosecution. The Cadre/Department allocated by appointing authority/SSB will not be changed under any circumstances by any authority/Department. The inter-se seniority of the appointee shall be as per the merit as it exists in the select list.

The appointment is subject to outcome of any petition(s) pending in any competent court/ Tribunal etc.
