Sanction is hereby accorded to the release of Rs.631.50 lakh (Rupees Six Crore Thirty One Lakh Fifty Thousand Only) as Grant-in-Aid in favour of Secretary/CEO, J&K Khadi and Village Industries Board for meeting expenditure on account of salary, pensionary benefits and other expenses during current financial year 2020-21.

- iii. There shall be no diversion /deviation in any case and funds shall be drawn, if immediately required and not just to park in the bank account.
- iv. The UCs of the advance drawal shall be furnished to the concerned quarters within stipulated time but before 31.03.2021.
