The advance drawal is subject to following conditions:-

1. The Department shall ensure early completion of pending accounts/audit and achievement of deliverables by above listed Corporation.
2. The Corporation shall get all the pending financial statements/accounts audited up to financial year 2019-20 & will ensure that the meetings of the Board of Directors/Governing Body are convened immediately as envisaged in Companies Act 2013 & compliance report shall be submitted to the BPE (Finance Department)
3. Director Finance, I&C Department shall vouch safe the availability of funds for the purpose they are meant for.
4. The expenditure shall be incurred after fulfillment of all requisite codal formalities as prescribed under GFR & after following due e-tendering procedures.
5. The expenditure shall be booked on approved items and with approval of the competent authority.
6. The funds shall be drawn if immediately required and should not be parked unnecessarily in the Bank account.
7. Necessary financial concurrence, AA/TS etc. wherever required, must be in place before booking the expenditure.
8. Detailed Red DC account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2021.
