Sanction is hereby accorded to the advance drawal of Rs.25.00 crore (Rupees twenty five crore) only under Capex Budget 2020-21 by Director, Industries and Commerce, Kashmir and its placement at the disposal of Managing Director, JK IT Infrastructure Development Company, out of the funds available with the Directorate under the scheme "Construction of IT Tower in Kashmir".

The sanction is subject to following conditions:-

1. Deputy Director (Planning)/CAO, Directorate of Industries & Commerce, Kashmir shall vouch safe the availability of funds for the purpose they are meant for.
2. The Department shall utilize the funds after ensuring the strict compliance of all due procedures as prescribed under GFR and Manual of Procurement of Goods and Services.
3. The funds shall be utilized with prior approval of competent authority and for the specific purpose as per the items of expenditure approved in the DPRs by the competent authority.
4. The AA/TS of the works should be in place and the expenditure in no case should exceed the allotted cost of the project.
5. The expenditure shall be incurred after observing all codal formalities and standing instructions issued by the Finance Department from time to time.
6. The funds shall not be available for re-appropriation or diversion/deviation at any level and there shall be no idle parking of the funds at all.
7. The Red DC Account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2021.
