Sanction is hereby accorded to the advance drawal of Rs.66.42 Lakh (Rupees Sixty Six Lakh & Forty Two Thousand) only under Capex Budget 2020-21 by Director, Industries and Commerce, Kashmir and its placement at the disposal of Managing Director, J&K SICOP, out of the funds available with the Directorate under the scheme "Development of I/E- Fencing for I/E Barsoo Ganderbal".

The sanction is subject to following conditions:-

1. Dy. Director (Planning)/ Chief Accounts Officer Directorate of Industries and Commerce, Jammu, shall vouch safe availability of funds in the Capex Budget 2020-21.
2. The Department shall ensure early completion of pending accounts/audit and achievement of deliverables by above listed Corporation.
3. The expenditure shall be incurred after fulfillment of all requisite codal formalities as prescribed under GFR & after following due e-tendering procedures.
4. The expenditure shall be booked on approved items and with approval of the competent authority.
5. The funds shall be drawn if immediately required and should not be parked unnecessarily in the Bank account.
6. The new works taken up for execution should be fully verified and should conform to the laid down procedures like Accord of Administrative Approval/Technical Sanction, e-tendering, furnishing of Geo-tagged photographs of projects etc.
7. Detailed Red DC account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2021.
8. Requisite utilization certificates shall be submitted to the concerned quarters with a copy to the Administrative Department within stipulated time period.
9. The funds shall not be available for diversion/re-appropriation at any level.
10. Controlling Officer shall make further releases to the executing agency in respect of only such New Works which shall be completed physically & financially during the current financial year 2020-21.

The funds are debitale as per following classifications:
