The advance drawal is subject to the following conditions:-


1. The Department shall incur the expenditure after fulfillment of all required codal formalities as prescribed under GFR and after following due e-tendering procedures.
2. The expenditure shall be booked on approved items and with approval of competent authority.
3. No idle parking of funds in Bank Accounts is allowed.
4. Necessary financial concurrence, AA/TS etc wherever required must be in place before booking the expenditure.
5. The detailed Red DC Account of the advance drawal shall be furnished to all the concerned quarters within stipulated time.

The expenditure shall be debit able to the object Heads:-

- i. Major head = 4852 – Capital Outlay on Iron & Steel Industries
- ii. Sub-Major Head = 02- Manufacture
- iii. Minor Head = 190- Investments in public sector & other undertakings
- iv. Group Head = 0011- General
- v. Sub-head = 0711-Investment in SIDCO
- vi. Detailed Head = 115- Works.


