2. All the codal formalities are completed before execution of the work.
3. e-Tendering shall be followed.
4. All the relevant provisions of the GFR 2017 shall be followed in letter and spirit.

5. That the encumbrance free land is available and the cost thereof is covered by the DPR cost, if at all involved. In case of departmental land, payment shall not be involved and loaded on the DPR cost.
6. There should be no cost and time over run during the execution of the project.
7. The project shall be executed as per standard specifications of the schedule of rates on which DPR has been formulated.
8. The project shall be funded under Capex Budget.


