Also, the utilization of the funds so released are subject to condition that hiring of staff on outsourcing basis in JKTPO shall be restricted to the minimum functional requirement of the organization and no further hiring of manpower shall be made without prior concurrence of Finance Department. Besides, the payment of emoluments shall be made as per the valid approved rates/contract conditions.
