
**Government Order No: 164-JK(IND) of 2022
Dated: 28.09.2022**

As recommended by the Jammu and Kashmir Services Selection Board, sanction is hereby accorded to the temporary appointment of Mr. Asif Ahmed Malik S/o Ghulam Ahmad Malik R/o Bharath (B) Village Bharath Doda, under RBA category, against the posts of class-IV in respective Divisional/District Cadre in the Directorate of Industries & Commerce, Jammu in Pay Level SL1 of Rs. 14800-47100, with immediate effect.

The appointee shall report to the Director, Industries & Commerce Department, Jammu in Udhyog Bhawan, Railway Head, Jammu within a period of 21 days from the date of issuance of this order. In case of failure to join within the stipulated period, the appointment shall be deemed to have been cancelled *ab-initio* without any further notice.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

- i. Academic/Technical Qualification Certificates.
- ii. Matriculation /Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the competent authority.
- v. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under self-employment scheme has been taken by the appointee.
- vi. Valid relevant category certificate, if required.



The salary of the appointees shall not be drawn and disbursed to him/her unless and until the satisfactory report/genuineness of the certificates is received.

Further, the appointment shall be cancelled *ab-initio*, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on and he shall also be liable for criminal prosecution. The Cadre/Department allocated by appointing authority/SSB shall not be changed under any circumstances by any authority/Department. The appointment of the candidate shall be governed by the "New Pension Scheme" and the inter-se seniority shall be fixed as per the merit reflected in the select list.

The appointment is subject to outcome of any petitions/(s) pending in any competent court/ Tribunal etc.


