



Subject: Deployment of employees of JK Cements Ltd to J&K SIDCO.

**Government Order No.202-JK(IND) of 2022
Dated:-01.12.2022**

Sanction is hereby accorded to the deployment of Mr. Mohammad Amin Masoodi, Plant Engineer (Mechanical) and Mr. Jagjit Singh, Plant Engineer (Mechanical) of J&K Cements Ltd. to J&K SIDCO, against vacant posts commensurate to their pay level/scale, for a period of one year or till the posts are filled up on regular basis or till the officials are recalled/retired, whichever is earlier, subject to the following conditions:-

- i. The salary of the officials shall be drawn by the Department against the available vacant posts commensurate to their pay scale as per the LPC issued by the concerned relieving authority or where the officials were earlier posted and without any deputation/deployment allowance.
- ii. COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Corporation.
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of the officials.
- iv. The salary shall be released in favour of the officials from the date they join their duties.
- v. They shall retain their lien, seniority and promotion prospects at their parent Corporation viz. JK Cements Limited.
- vi. The officials shall remain on the rolls of J&K Cements Limited and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.
- vii. The above arrangement shall be reversible without any notice;
- viii. The posts vacated by the officials in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.
- ix. The officials so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that they have no right to claim for permanent absorption in the department/Corporation and will not approach any Hon'ble Court of Law for the said purpose.



- x. The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director JK Cements Limited/or the office where from they relieved in their LPCs to be issued.


