Subject:- Deployment of Employee of Handloom & Handicrafts Corporation.

**Government Order No. 36-JK(IND) of 2022
Dated:- 09.03.2022**

Sanction is hereby accorded to the deployment of Gh. Rasool, Santry, J&K Handloom & Handicraft Corporation to Directorate of Handicrafts & Handloom Kashmir against the vacant direct quota post equivalent to his pay scale for a period of one year or till the post is filled up on regular basis, whichever is earlier, subject to the following conditions:-

- i. The salary of the official shall be drawn by the Directorate of Handicrafts & Handloom, Kashmir, against the available vacant post under direct recruitment quota equivalent to his pay scale, as per the LPC issued by the Managing Director, Handloom & Handicrafts Corporation and without any deputation/deployment allowance.
- ii. COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation.
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of the official.
- iv. The salary shall be released in favour of the official from the date he join his duties.
- v. He shall retain his lien, seniority and promotion prospects at his parent Corporation viz. JK Handloom & Handicrafts Corporation.
- vi. The official shall remain on the rolls of J&K Handloom & Handicrafts Corporation and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.
- vii. The above arrangement shall be reversible without any notice;
- viii. The post vacated by the official in J&K Handloom & Handicrafts Corporation shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.
- ix. The official shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he has no right to claim for permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.
- x. The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director, Handloom & Handicrafts Corporation.
