Sanction is hereby accorded to the advance drawal of funds amounting to Rs.100.00 Lakh (Rupees one hundred lakh) only under Capex Budget 2021-22 in favour of Director, Handicrafts & Handloom, Kashmir for procurement of Optical based fiber Diameter Analyzer (OFDA)-4000 out of the funds available with the Directorate under the scheme "Up-gradation Lab facility at IICT/Quality Control Srinagar".

The sanction is subject to the following conditions:-

1. The expenditure shall be made only after fulfillment of all requisite codal formalities as prescribed under GFR & after following due e-tendering procedures.
2. Dy. Director (Planning)/ Chief Accounts Officer Directorate of Handicrafts & Handloom, Kashmir, shall vouch safe availability of funds in the Capex Budget 2021-22.
3. The expenditure shall be booked on approved items and with the approval of the competent authority.
4. Detailed Red DC account of the advance drawal shall be furnished to all the concerned quarters within stipulated time but before 31.03.2022.
5. Requisite utilization certificates shall be submitted to the Administrative Department within stipulated time period.
6. The funds shall not be available for diversion/re-appropriation at any level.
