**Subject:- Deployment of Mr. Hilal Ahmad Lone, Section Officer, JK Cement to J&K Handicrafts (S&E) Corporation.**

**Government Order No. 125 – (JK) IND of 2023  
Dated: 19.05.2023**

In terms Article 52-C (i) of Vol-I of J&K CSR, 1956, sanction is hereby accorded to the deputation of Shir. Hilal Ahmad Lone, Section Officer, Marketing JK Cements Limited to J&K Handicrafts and Handloom(S&E) Corporation against vacant post commensurate to his pay level/scale, for a period of two years or till the post is filled-up on regular basis or till the official is recalled/retired, whichever is earlier, subject to the following conditions:-

- 1) The salary of the official shall be drawn by the J&K Handicrafts(S&E) Corporation against the available vacant post as per his LPC issued by the Director, Geology & Mining, and without any deputation/deployments allowance.
- 2) COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation.
- 3) The lien and promotion prospectus of the official shall be retained in JK Cement during his period of deputation to J&K Handicrafts(S&E) Corporation.
- 4) The official so deputed/deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he has no right to claim for permanent absorption in the H&H Corporation and will not approach any Hon'ble Court of Law for the said purpose.
- 5) The pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director, H&H Corporation in his LPC to be issued by Director, Geology & Mining.
- 6) No arrears shall be released in favour of the Official from the date he joins his duties.
- 7) The official shall remain on the rolls of J&K Handloom and Handicrafts Corporation and shall not opt for the golden Handshake Scheme which shall be certified by the concerned organization.
- 8) The above arrangement shall be revise-able without any notice.
