Sanction is hereby accorded to the release and advance drawal of Rs.27.75 lakh (Rupees Twenty Seven Lakhs and Seventy Five Thousand) only under Capex Budget 2023-24 by Director, Industries and Commerce Jammu and its placement with Managing Director, JK SIDCO for the project **"Up-gradation of Existing Infrastructure in Industrial Estates under Micro & Small Enterprises-Cluster Development Programme (MSE-CDP) - Battal Ballian Phase-I Udhampur"**.

3. The expenditure shall be incurred after fulfillment of all requisite codal formalities as prescribed under GFR and after following due e -tendering procedures.
4. The expenditure shall be booked on approved items and with approval of the competent authority.
5. Detailed Red DC Account of the Advance Drawal shall be furnished to all the concerned quarters within stipulated time, but before 31.03.2024.
6. Requisite utilization certificate of previous funds released (if any), shall be submitted to the concerned quarters with a copy to the Administrative Department within stipulated time period.
7. The funds shall not be available for diversion/re-appropriation at any level.
8. That the amount shall be credited to CNA Account maintained by the Director Finance, Industries and Commerce Department bearing Account No.01110040510000167-Micro and Small Enterprises CDP maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar.


