WHEREAS, on the recommendations of J&K Service Selection Board, sanction was accorded to the temporary appointment of Mr. Manik Singh S/o Mr. Pawan Singh, R/o Nagri Parole Mirpur Ram Kathua as MTS against Class-IV post in the Directorate of I&C, Jammu in pay Level SL1 of Rs.14800-47100 vide Government Order No.256-IND of 2021 dated 16.12.2021;

AND WHEREAS, the Directorate of Industries and Commerce Department, Jammu vide letter dated 20.09.2023 has informed that Mr. Manik Singh MTS has submitted his resignation to General Manager, District Industries Centre, Kathua for acceptance w.e.f. 23.08.2022 due to some personal reason;

AND WHEREAS, the General Manager DIC, Kathua has also forwarded the copy of undertaking furnished by the official to the Directorate of I&C Jammu vide letter dated 28.09.2022 and informed that there is nothing outstanding against the official with respect to their office;

And WHEREAS, the official has also furnished an Affidavit, where under he has affirmed that due to some personal reasons he has filed his resignation, and want to leave his service besides, he will not claim any right of job in future.

NOW THEREFORE, in exercise of the powers conferred under Rule 22(i)(b) of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956, the probation of Mr. Manik Singh S/o Mr. Pawan Singh, R/o Nagri Parole Mirpur Ram Kathua is hereby terminated and he is discharged from the service w.e.f. 23.08.2022, on his own request.
