Sanction is hereby accorded to the advance drawal of Rs.30.72 lakh (Rupees Thirty Lakh and Seventy Two thousand) only under Capex Budget 2023-24 by the Director, Handicrafts & Handloom, Jammu for its further placement at the disposal of NECBDC, Assam for implementation of the approved scheme viz. **"Construction of CFC at Sumb, Samba for promotion and Development of Bamboo Craft"** out of Capex Budget 2023-24.

The advance drawal is subject to following conditions:-

1. That all the codal formalities & procedures as required under GFR/Rules be followed while incurring the expenditure.
2. That the work shall be executed through the agency having vast experience and technical expertise in the field.
3. That the authority through whom the work is intended to be executed shall be duly authorized by the competent authority or be selected through competitive bidding process only.
4. That the work order or agreement to accomplish the work shall be placed only after ascertaining the reason ability of rates.
5. That the Red Account be submitted to the concerned quarter immediately after completion of the job under intimation to the Administrative Department.
6. Deputy Director Planning/Accounts Officer of the Directorate of H&H Jammu shall vouch safe the availability of funds for the purpose they are meant for.
7. The funds shall not be available for diversion/re-appropriation at any level.
8. The expenditure shall be made on admissible items only as approved by the competent authority.
9. The funds shall be drawn immediately if required and shall not be parked unnecessarily in the Bank account.

The expenditure shall be debit able to the object Heads:-

- i. Major head = 4851 – Capital Outlay on Village & Small Industries
- ii. Minor Head = 104- handicraft Industries
- iii. Group Head = 0011- General
- iv. Sub-head = 0884-Handicraft and Handloom Jammu


