1. The Director Finance, I&C Department shall vouch safe the availability of funds for the purpose they are meant for.
2. The expenditure shall be incurred after fulfillment of all required codal formalities as prescribed under GFR and after following due e-tendering procedures.
3. The expenditure shall be booked on approved items and with approval of the competent authority.
4. The funds shall be drawn immediately if required and shall not be parked unnecessarily in the Bank account.
5. The Necessary financial concurrence, AA/TS etc. wherever required, shall be in place before booking the expenditure.
6. The Detailed Red DC account of the advance drawal shall be furnished to all the concerned quarters within stipulated time.
7. The concerned (Handicraft and Handloom (S&E) shall ensure early completion of pending Accounts/Audit and achievement of deliverables.


