**Subject: Constitution of Standing Committee.**

**Government Order No. 47 -JK (IND) of 2023**

**Dated: 07.02.2023**

Sanction is hereby accorded to the constitution of a Standing Committee, with the following composition, to remove difficulties and resolve issues of the investors viz-a-viz land allotments and other land related matters:

The Terms of Reference (ToRs) of the above committee shall be as under:-

The Committee shall:-

1. Deliberate upon and suggest ways to remove difficulties of the investors viz-a-viz land allotment as per provisions of the J&K Land Allotment Policy, 2021-30, and any other relevant policy.
2. Examine/suggest way-ahead for allotment cases of those applicants who have applied for alternate sites in lieu of allotment patches.
3. Suggest way forward for the cases of cancellations as per APCC decision, as well as for allotment against cancellation of those cases of fresh land allotment who have not responded till date.
4. Compile data and other relevant details regarding non feasible/non-suitable patches where the development cost is too high or where land acquisition/demarcation issues may be there; and
5. Any other mandate/matter assigned to the Committee by the Administrative Secretary from time to time.

The Committee shall meet once a week internally and at least once every fortnight with land allottees/ potential allottees, and take stock of their problems. The land allottees shall be free to attend the meeting online.

The selected cases shall also be brought to notice of the Administrative Secretary for interaction on a one to one basis.
