

The advance drawal is subject to the following conditions:-

1. The Director Finance, I&C shall vouch safe the availability of funds for the purpose they are meant for.
2. The Department shall incur the expenditure after fulfillment of all required codal formalities as prescribed under GFR and after following due e-tendering procedures.
3. The expenditure shall be booked on approved items and with approval of competent authority.
4. The funds shall be drawn immediately if required and shall not be parked unnecessarily in the Bank account.
5. Necessary financial concurrence, AA/TS etc wherever required must be in place before booking the expenditure.
6. The detailed Red DC Account of the advance drawal shall be furnished to all the concerned quarters within stipulated time.
7. The J&K Handloom Development Corporation Ltd. shall ensure early completion of pending Accounts/Audit and achievement of deliverables.
