Subject: Deployment of Mr. Nazir Ahmad Lone, Machine Attendant, J&K Cements Ltd.

**Government Order No. 145 -JK(IND) of 2024
Dated: 16 .12.2024**

Mr. Nazir Ahmad Lone, Machine Attendant, J&K Cements Ltd (attached with MD, J&K Cement Ltd) is hereby deployed to J&K Khadi & Village Industries Board, against available post commensurate to his pay level/scale, for a period of one years or till the post is filled up on regular basis or till the official is recalled/retired, whichever is earlier, subject to the following conditions:

- i. *The salary of the official shall be drawn by the Department against the available vacant post commensurate to his pay scale/level as per the LPC issued by the Directorate of Handicraft and Handloom, Kashmir without any deputation/deployment allowance.*
- ii. *COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation.*
- iii. *No arrears on account of pay or COLA/DA shall be paid in favour of the official.*
- iv. *The salary shall be released in favour of the official from the date he join his duties.*
- v. *He shall retain his lien, seniority and promotion prospects at his parent Corporation viz. JK Cements Limited.*
- vi. *The official shall remain on the rolls of J&K Cements Limited and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vii. *The above arrangement shall be reversible without any notice;*
- viii. *The post vacated by the official in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- ix. *The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he/she has no right to claim for permanent absorption in the department/Corporation and will not approach any Hon'ble Court of Law for the said purpose.*
- x. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director JK Cements Limited /Directorate of Handicraft and Handloom Kashmir, in his LPCs to be issued.*


