In continuation to Government Order No:- 195-JK(Ind) of 2023 Dated 20-10-2023 sanction is hereby accorded to the advance drawal of Rs.35.11 Lakh (Rupees Thirty Fifty Lakh & Eleven thousand only) under Capex Budget 2023-24 in favour of Director Handicraft & Handloom Jammu for further placement to North East Cane and Bamboo Development Council (NECBDC), Assam for implementation of the approved scheme " **Construction of CFC at Sallan Kathua for promotion and Development of Bamboo Craft.**

The advance drawal is subject to the following conditions:-

1. That all the codal formalities & Procedures as required under GFR/Rules be followed while incurring the expenditure.
2. This advance drawl is subject to the provision of Model Code of Conduct.
3. That the work shall be executed through the agency having vast experience and technical expertise in the field.
4. That the authority whom the work is intended to be executed shall be duly authorized by the competent authority or be selected through competitive bidding process only.
5. That the work order or agreement to accomplish the work shall be placed only after ascertaining the reasonability of rates.
6. Director Handicraft and Handloom Jammu shall submit the Red accounts of advance drawals to the Accountant General and furnish the clearance certificate to the Administrative Department.
7. Deputy Director (Planning)/Accounts officer of the Directorate of Handicraft and Handloom Jammu shall vouchsafe the availability of funds for the purpose they are meant for.
8. The funds shall not be available for diversion/re-appropriation at any level.
9. The expenditure shall be made on admissible items only as approved by the Competent Authority.
10. The funds shall be drawn immediately, if required and shall not be parked unnecessarily in the Bank account.


