2. The Department shall ensure the thorough compliance with GFRS, CVC guidelines and reasonability of rates.



3. The expenditure shall be booked on approved items and with approval of competent authority.
4. The funds should be drawn immediately, if required and should not be parked unnecessarily in the Bank accounts.
5. Necessary financial concurrence, AA TS etc wherever required, must be in place before booking the expenditure.
6. The detailed Red DC Account of the advance drawl shall be furnished to all the concerned quarters within stipulated time.
7. FA/ CAO JKSIDCO and SICOP shall vouchsafe the availability of funds for the purpose they are meant for.
8. The funds shall not be available for diversion/re-appropriation at any level.


