1. The nomination of non-official members of the Advisory Board will be suggested by a committee constituted under the chairmanship of Chief Secretary, J&K. The committee will take into account the diversity and expertise of the applicants, as well as their contribution and commitment to the objectives of the Advisory Board.

2. Not more than 15 non official members shall form part of the Advisory Board at a point of time. These members shall be on rotation tenure of 3 years and shall be eligible for reappointment.

3. The Board will meet at least on quarterly basis to discuss and review the progress of various objectives and activities undertaken during its tenure.

4. The Secretariat of the Advisory Board shall be housed in J&K Trade Promotion Organization (JKTPO). The operational costs of the Advisory Board including meeting expenses or any other cost associated with Board's activities will be borne out of funds available with JKTPO.

The key objectives of the Advisory Board will be to:

- a. provide advice on measures to create an industry-friendly environment in Jammu and Kashmir, simplification of government procedures, and streamlining of laws to increase employment opportunities.
- b. provide advice on preparing strategies to attract area-specific and sector-wise investments in the Jammu and Kashmir.
- c. deliberate on the need for infrastructure relevant for promoting trade and identification of impediments and infrastructure gaps and suggesting solutions to address them.
- d. Identify the latest Sector-specific technological advancements and strategize measure to improve its adoption by industries.
- e. provide guidelines to various regions of Union Territory on economic development including industrialization of local areas.
- f. advise the government on measures that result in development of MSMEs.
- g. suggest key initiatives to increase skill development in the Union Territory. To identify the skills needed in industrial sector and formulate strategies to cultivate these skills to enhance the industrial growth.
- h. to advise the Industries and Commerce Department with respect to long term growth of J&K and promote sustainable industrialization.


