- 5. Director Handicrafts and Handloom Jammu shall submit the Red accounts of advance drawal to the Accountant General and furnish the clearance certificate to the Administrative Department.
- 6. Deputy Director (Planning)/Accounts officer of the Directorate of Handicraft and Handloom Jammu shall vouchsafe the availability of funds for the purpose they are meant for.
- 7. The funds shall not be available for diversion/re-appropriation at any level.

8. The expenditure shall be made on admissible items only as approved by the Competent Authority.

9. The funds shall be drawn immediately, if required and shall not be parked unnecessarily in the Bank account.
