Subject:- Establishment of Industrial Estate, Bhagthali, Kathua.

Whereas, pursuant to Administrative Council Decision No. 49/3/2022 dated 15.03.2022, Revenue Department, J&K vide Government Order No. 64-JK (Rev) of 2022 dated 25.03.2022, transferred state land measuring 2949 Kanal 11 Marla in favour of Industries and Commerce Department reserved for Industrial Estate Bhagithali Kathua; and

Whereas, Director General, Industries and Commerce, Jammu vide letter No. DI&C/M&P/J/845/5537-40 dated 15.03.2022 followed by letter No. DI&C/M&P/J/845/2436-39 dated 03.01.2023 placed indents for transfer of state land measuring 2714 kanal for establishment of Industrial Estate, Bhagithali, Kathua; and

Whereas, subsequently, the Administrative Council vide Decision No. 03/01/2024 dated 18.01.2024 has approved the transfer of 2183 Kanal 14 Marla state land for industrial purpose and Revenue Department J&K has accordingly transferred the said land in favour of Industries and Commerce Department for establishment of Industrial Estate vide Government Order No. 23-JK(Rev) of 2024 dated 31.01.2024; and
