Subject:- Deployment of Mr. Nissar Ahmad Mir (Junior Assistant) , Mr. Manzoor Ahmad Sheikh (Sweeper) and Ranjeet Singh (Helper) of JKHDC.

Sanction is hereby accorded to the deployment of Mr. Nissar Ahmad Mir (Junior Assistant), Mr. Manzoor Ahmad Sheikh, Sweeper, and Ranjeet Singh, Helper, of J&K Handloom and Handicrafts Development Corporation; to J&K Khadi & Village Industries Board, against available post commensurate to their pay level / scale, for a period of one year or till the post is filled up on regular basis or till the officials are recalled/retired, whichever is earlier, subject to the following condition:-

- i. *The salary of the officials shall be drawn by the office of Secretary/CEO KVIB against the available vacant post under direct recruitment quota as per the LPC issued by the Managing Director J&K Handloom & Handicrafts Corporation and without any deputation/deployment allowance.*
- ii. *COLA/DA shall be paid at the rates, as was being paid to them and the subsequent release of COLA/DA shall be applicable to them as and when the same is released by the concerned Corporation.*
- iii. *No arrears on account of pay or COLA/DA shall be paid in favour of the officials.*
- iv. *The salary shall be released in favour of the officials from the date they join their duties.*
- v. *They shall retain their lien, seniority and promotion prospects at their parent Corporation viz. JK Handloom & Handicrafts Corporation.*
- vi. *The officials shall remain on the rolls of J&K Handloom & Handicrafts Corporation and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vii. *The above arrangement shall be reversible without any notice;*
- viii. *The post vacated by the officials in J&K Handloom & Handicrafts Corporation shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- ix. *The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that they have no right to claim for permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.*
- x. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director Handloom & Handicrafts Corporation in their LPCs.*


