Whereas, General Administration Department, J&K, vide various Government Orders apportioned employees serving on substantive basis in erstwhile State J&K, to the UT of Ladakh on the basis of options exercised by them. Besides, vide Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, it was ordered that apportionment of remaining employees referred by UT of Ladakh shall be considered upon after due verification / certification of their service records / credentials.

Whereas, vide Government Order No. 138-IND of 2021 dated 21.06.2021, Industries and Commerce Department, J&K accorded sanction to the apportionment of assets and liabilities of erstwhile J&K State on "as is where is" basis to the UT of Ladakh. Also, vide Government Order No. 14-JK(IND) of 2023 dated 09.01.2023 Managing Director, J&K SICOP was authorized to immediately initiate the process of apportionment of assets and liabilities of SICOP Ladakh strictly in terms of S.O. 339 dated 30.10.2020, in a time bound manner.

Whereas, Annexure I to Notification No. 339 dated 30.10.2020, inter alia, provides as under: -

- The allocation of employees between the UT of J&K and UT of Ladakh shall be made on the basis of the options given by them as follows.
 - a. if the number of employees opting for the UT of Ladakh is less than the number of posts transferred to the UT of Ladakh, all these employees shall be allocated to UT of Ladakh. As for the remaining vacancies, the Lieutenant Governor of the UT of J&K shall allocate non-optees, based on the suitable criterion evolved by the UT of J&K.
 - b. if the number of optees is more than the number of posts to be transferred to the UT of Ladakh, then the Lieutenant of J&K shall allocate optees, based on the suitable criterion evolved by the UT of J&K.

Whereas, in terms letter dated 02.05.2023 from J&K SICOP, the employees have opted their options and all domiciles of Ladakh have opted for Ladakh division and J&K domiciles have preferred to be in J&K.

Whereas, during a meeting on the subject chaired by Commissioner/Secretary, General Administration Department on 24.05.2023, it was directed that a copy of handover/takeover of Assets etc. between J&K SICOP and SIDCO Ladakh be shared with GAD immediately through Administrative Department, I&C Department. Subsequently, in keeping with the J&K SICOP Communication dated 03.05.2023, the Department vide letter dated 08.06.2023, requested GAD to issue formal orders in favour of the officials.

Whereas, the Board of Directors of J&K SICOP in its meeting dated 21.12.2023 "Resolved that Managing Director, SICOP is authorized to Handover all assets/liabilities of J&K SICOP in UT of Ladakh to Sindhu Infrastructure Development Corporation (SIDCO)."
