**Subject: - Final Seniority list of Handicrafts Training Officer (HTO)/Quality Control Inspector (QCI) as it stood on 01.01.2023.**

**Government Order No. 24 -JK (IND) of 2025  
Dated: 05 .03.2025**

Whereas, a tentative seniority list of **Handicrafts** Training Officer (HTO)/Quality Control Inspector (QCI) as it stood on 01.01.2023 was issued vide notification No. IC/HHD/13/2023-02 dated 31.07.2023; and

Whereas, by issuance of the aforesaid tentative seniority list, objections were sought from the members of the service to be submitted within 15 days of the issuance of the said list;

Whereas, the department has received the following objections:-

01.	Imtiyaz Ahmad Wagay, QCI	The official has requested that he belongs to RBA Category while as he has been shown as OM Category and also enclosed the supporting document
02.	Subash Chander, HTO	The official has submitted that the date of birth of <b>Sh. Altaf Hussain Mir</b> (HTO) figuring at S. No. 8 in the seniority list is mentioned as 18.03.1969, while his date of appointment is indicated as 05.02.1985. This indicates that he might have joined the government service at an age <b>below 16 years</b> which needs a thorough verification and necessary correction.
03	Showkat Ahmad	The official has submitted that he is senior to Imtiyaz Ahmad Wagay and requested to maintain appropriate

	Malik, QCI	position to both officials and the supporting document is also enclosed.
04	Joginder Mangol I/c Assistant Director.	The officer has submitted that the credentials viz, name, date of birth and date of 1 <sup>st</sup> appointment in the tentatively seniority list has been mentioned incorrectly. He has furnished his credentials and has requested to correct his credentials in the said seniority list and he has also enclosed the supporting documents in his representation.

Whereas, the details of the submission made in the above representation were taken up the matter to Concerned Directorate to examine the objections and furnish the detail report to this department vide this departments letter of even number dated 08.09.2023 and followed by chain of reminders, who in turn have reported as under;

- 1) Regarding the official namely Imtiyaz Ahmad Wagay, Quality Control Inspector/ it has been reported that the said Quality Control Inspector, has been selected/ appointed under RBA category and he belongs to RBA category instead of OM category.
- 2) Deputy Director Handicrafts, Quality Control, Srinagar has reported that the official namely Mr. Showkat Ahmad Malik, quality Control Inspector figuring at Sr. No. 14 in the said list is senior to Mr. Imtiyaz Ahmad Wagay, Quality Control Inspector, who figures at Sr. No. 13, as per the selection/ merit list.
- 3) Assistant Director Handicraft, Ganderbal has reported that the name of one Handicrafts Training Officer figuring at Sr. No. 34 in the said list has been mentioned as **Masooda Jan** while as her name as per service records is **Maqsooda Jan** and name of another Handicraft Training Officer has been mentioned as **Mohammad Ashraf Sofi** instead of **Mohd Ashraf Sofi** figuring at Sr. No. 16 in the said list.
- 4) As reported by the Director, H&H, Kashmir with regard to lower age relaxation has been accorded by the government vide



Government Order No. 129-IND of 1986 dated 16.01.1986 to Mr. Altaf Hussain Mir, HTO and the said Government Order could not be verified in his office as all the records of the Directorate prior to 1990 have gutted in fire and the same be got verified at the level of Administrative Department, as the same does neither bear signatures of Additional Secretary to Government or Under Secretary to Government, I&C Department.

Whereas, the Government Order register pertaining to year 1986 is not available in the record and authorities has advised to depute Under Secretary to enquire from GAD if relevant register regarding age relaxation is available with GAD. If not available, write to Director H&H Kashmir.

Whereas, the matter was again taken up with Director Handicrafts & Handloom, Kashmir vide letter dated 06.11.2024 and with the requested to get the lower age relaxation issue of Altaf Hussain Mir verified from subordinate offices if available and certify the same.

Whereas, Director, H&H, Kashmir has informed that the matter was taken up with Assistant Director Handicrafts, Budgam for clarification. The concerned DDO has furnished an attested copy of Service Book of Mr. Altaf Hussain Mir, HTO, perusal of which reveals that the lower age relaxation granted in his favour vide Government Order dated 16.01.1986 has been entered in his service records under the seal and signature of the then Joint Director, Handicrafts, Kashmir. However prevalence of format of order for relaxation of age where additional secretary/under Secretary of the I&C department did not bear signatures rather order being signed by Joint director Handicraft could not be verified. Further, informed that Mr Subash Chander who has





submitted objection to tentative seniority list regarding lower age issue of Mr Altaf Hussain Mir has withdrawn his objections.

Whereas, the above mentioned objections thoroughly examined and corrections/insertions wherever necessary have been made in the said tentative seniority list, as were brought forward by these officials through medium of their representations.

Now, therefore, final seniority list in respect of Handicrafts Training Officers of Handicrafts & Handloom department(HTO)/Quality Control Inspectors (QCI) of Handicraft Department, J&K as it stood on 01.01.2023 is issued as **Annexure-A** to this Government Order for information of all concerned members of the service.


