In continuation to Government Order No. 54-JK (IND) of 2024 dated 22-03-2024 sanction is hereby accorded to the advance drawal of Rs.26.00 Lakh (Rupees Twenty Six Lakh) only under Capex Budget 2024-25 in favour of Director Handicrafts & Handloom Jammu for its further placement to North East Cane and Bamboo Development Council (NECBDC), Assam for implementation of the approved scheme" Construction of CFC at Sumb, Samba for promotion and Development of Bamboo Craft aggregating the advance drawal of funds to Rs.158.34 lakh for the project.

The advance drawal is subject to the following conditions:-

1. That all the codal formalities & Procedures as required under GFR/Rules be followed while incurring the expenditure.

That the work shall be executed through the agency having vast experience

and technical expertise in the field.

3. That the authority to whom the work is intended to be executed shall be duly authorized by the competent authority or be selected through competitive bidding process only.

4. That the work order or agreement to accomplish the work shall be placed

only after ascertaining the reasonability of rates.

5. Director Handicrafts and Handloom Jammu shall submit the Red accounts of advance drawal to the Accountant General and furnish the clearance certificate to the Administrative Department.

6. Deputy Director (Planning)/Accounts officer of the Directorate of Handicraft and Handloom Jammu shall vouchsafe the availability of funds for the

purpose they are meant for.

The funds shall not be available for diversion/re-appropriation at any level.

- 8. The expenditure shall be made on admissible items only as approved by the Competent Authority.
- 9. The funds shall be drawn immediately if required and shall not be parked unnecessarily in the Bank account.
