Subject: Deployment of Mr. Javid Ahmad Bhat, Office Assistant, J&K Cements Ltd.

**Government Order No. 31-JK(IND) of 2025
Dated: 11.04.2025**

Sanction is hereby accorded to the deployment of Mr. Javid Ahmad Bhat, Office Assistant, J&K Cements Limited to the Director, Handicrafts & Handloom, Kashmir against a vacant post commensurate to his pay level/grade, for a period of one year, on the following terms and conditions:

- i. *The salary of the official shall be drawn by the Department against the available vacant post commensurate to his pay scale/level as per the LPC without any deputation/deployment allowance.*
- ii. *COLA/DA shall be paid at the rates, as were being paid to him earlier and the subsequent release of COLA/DA shall be applicable to him as and when released by the concerned Corporation/Government.*
- iii. *No arrears on account of pay or COLA/DA shall be paid in favour.*
- iv. *The salary of the official shall be released from the date he joined in the Administrative Department, i.e. w.e.f. 01.03.2025.*
- v. *The Official shall retain his lien, seniority and promotion prospects at his parent Corporation i.e. J&K Cements Limited.*
- vi. *The official shall continue to remain on the rolls of J&K Cements Limited and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vii. *The above arrangement shall be purely temporary and reversible without any notice;*
- viii. *The post vacated by the official in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- ix. *The official shall furnish an undertaking duly attested by the 1st Class Magistrate, the effect that he shall not claim for permanent absorption in the department and shall not approach any Hon'ble Court of Law in this regard.*
- x. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification from J&K Cement Limited.*


