- vi. The official shall continue to remain on the rolls of J&K Cements Limited and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.
- vii. The above arrangement shall be purely temporary and reversible without any notice;

viii. The post vacated by the official in J&K Cements Limited shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.

ix. The official shall furnish an undertaking duly attested by the 1 st Class Magistrate, the effect that he shall not claim for permanent absorption in the department and shall not approach any Hon'ble Court of Law in this regard.

x. The Pay level and designation shall not be taken as authentic and shall be subject to

further verification from J&K Cement Limited.
