**Subject:- Deployment of Mr. Ghulam Mohi-Ud-Din Bhat (Weaver) of J&K Handicrafts & Handloom Corporation.**

**Government Order No. 53- JK(IND) of 2025**

**Dated: 10.06.2025**

Sanction is hereby accorded to the deployment of Mr. Ghulam Mohi-Ud-Din Bhat, Weaver, of J&K Handicrafts & Handloom Corporation (presently deployed with the Directorate of Handicrafts & Handloom Jammu) to the J&K Khadi & Village Industries Board, against an available post commensurate with his pay level / scale, for a period of one year or till the post is filled up on regular basis, or till the official is recalled / retired, whichever is earlier, subject to the following condition:-

- i. The salary of the official shall be drawn by the office of Secretary/CEO KVIB against the available vacant post under direct recruitment quota as per the LPC issued by the Director Handloom & Handicrafts, Jammu and without any deputation / deployment allowance.*
- ii. COLA/DA shall be paid at the rates, as was being paid to him and the subsequent release of COLA/DA shall be applicable to him as and when the same is released by the concerned Corporation.*
- iii. No arrears on account of pay or COLA/DA shall be paid in favour of the official.*
- iv. The salary shall be released in favour of the official from the date he join his duties.*
- v. He shall retain his lien, seniority and promotion prospects at his parent Corporation viz. J&K Handloom & Handicrafts Corporation.*
- vi. The official shall remain on the rolls of J&K Handloom & Handicrafts Corporation and shall not opt for the Golden Handshake Scheme which shall be certified by the concerned Organization.*
- vii. The above arrangement shall be reversible without any notice;*
- viii. The post vacated by the official in J&K Handloom & Handicrafts Corporation shall be deemed to have been frozen and shall not be filled up by promotion or by direct recruitment.*
- ix. The official so deployed shall furnish an undertaking duly attested by the 1st Class Magistrate stating therein that he has no right to claim for*



*permanent absorption in the department and will not approach any Hon'ble Court of Law for the said purpose.*

- x. *The Pay level and designation shall not be taken as authentic and shall be subject to further verification by Managing Director Handloom & Handicrafts Corporation in their LPCs.*


