The amount of retirement benefits so authorized shall be treated as liability towards the Government of J&K and shall be reflected appropriately in assets/liabilities statement of JKCL and the equivalent amount shall be remitted back to the Government of J&K as and when the sale out/liquidation of assets of JKCL is settled.
- 3. The expenditure shall be booked with approval of the competent authority and the amount shall not be parked unnecessarily in the Bank accounts.
- 4. The detailed Red DC Account of the advance drawl shall be furnished to all the concerned quarters within stipulated time.
- 5. The expenditure shall on this account shall be booked to following head of account:
