**Subject:** Draft partial modifications of gazetted as well as non-gazetted recruitment rules of the J&K Handloom Development Department.

*Whereas,* instructions have been issued by the General Administration Department/ARI & Trainings Department, from time to time impressing upon for finalization/up-dation of Recruitment Rules of Subordinate/Gazetted Cadres of the Departments;

*Whereas,* vide Government Order No. 155-IND of 2021 dated 06.08.2021,

- I. Re-designation of the post of Accountant-cum-store-Keeper to Assistant Handloom Training Officer(AHTO)
- II. Creation of 22 posts of Handloom Training officers (HTO) by corresponding reduction of 25 posts of AHTOs.

*Whereas,* the changes caused by this order needs to be incorporated into the existing recruitment rules of the Handloom Development Department by way of carrying partial modification of Gazetted as well as non-gazetted recruitment rules of the department;

*Whereas,* both the Directorate of Handicrafts & Handloom Department Kashmir /Jammu have furnished the proposal regarding updation of SRO- 84 of 2006 & SRO-164 of 1993 (J&K Handloom Development Gazetted /Non-Gazetted Service Recruitment Rules) & SRO-922 Schedule-I;

*Whereas,* on the basis of details provided by the respective Directorates and further examination thereof in the department, the drafts proposal for partial amendment in SRO 84 dated 9th March , 2006 schedule-II (gazetted), **SRO-164 dated 1<sup>st</sup> September, 1993 Schedule -III (Executive) & SRO-922 schedule-I, J&K Handloom Development (Non-Gazetted) Recruitment Rules, 1993** are examined in the Department and draft notification J&K, Handloom Development Department (Gazetted/Subordinate) have been framed.





S.O. \_\_\_\_ In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Lieutenant Governor hereby makes the following amendments shall be made in the Jammu and Kashmir J&K, Handloom Development Department (**Non-Gazetted**) Service Rule 1993.

**In Schedule-III (EXECUTIVE)**


**In Class-II, Category A-I** under the column Designation name of the post Handloom Training Officer shall be inserted and under the column method of recruitment following shall be inserted against the post of Handloom Training Officer;

*100% By promotion from Class IV category I (Assistant Handloom Training Officers) having minimum 05 years service as such in the same Category.*

**In Class- II Category -B** method of recruitment appearing as 33% by promotion from Class-IV, category H having at least five years service as such 67% by promotion from Class-IV, category I with at least 5 years service as such shall be omitted **and in place of it the following** shall be substituted against the post of Extension Officer:

*100% by promotion from Class IV Category H (Assistant Extension Officers) having minimum 05 years service as such in the same category.*

**In Class- IV Category -I, name of the post appearing under the column Designation as Accountant-cum-Storekeeper shall be ommitted and to be substituted with word Assistant Handloom Training Officer and word Graduate from any recognized University appearing under the columns **Minimum qualification for direct recruitment** shall be omitted and to be replaced with the word Graduate from any recognized University (or) three years diploma in Handloom/ Textile technology from recognized institute.**

S.O. \_\_\_\_ In exercise of the powers conferred by proviso to Article 309 of the Constitution, the Lieutenant Governor hereby makes the following amendments in the Jammu and Kashmir J&K, Handloom Development Department (**Gazetted**) Service Rule 2006.

**In Schedule-II**

In Class-V, existing method of recruitment for the post of Assistant Director is omitted and following method of recruitment shall be substituted;

I. 50% by Direct Recruitment through Combined Services competitive Examination.

**II. 50% by Promotion:**

a). 35% by promotion from the category of Handloom Training Officers on the basis of combined seniority of both Divisions having not less than 05 years service as such.

b). 15% by promotion from Class II category A&B of **Schedule-III** (Executive) i.e supervisors/Extension Officers and Assistant Registrar from Class I of **Schedule-IV** of Cooperative Sector of J&K Handloom Development Department (Subordinate) services having 05 years service as such on the basis of combined seniority and having the qualification of Graduation or 03 years Diploma in Handloom/Textile Technology from any recognized Institution.
